Catalog Description	The student examines significant health policy issues. Special emphasis is given to public policies with broad implications, such as Medicare, Medicaid, health insurance reform, and health system costs. The policy decision-making process is explored and methods and approaches for the study of policy issues are considered. American health policy issues are placed in the international context by comparison with selected other health systems.
Prerequisites	HLTH 5000 is a prerequisite for all other courses in the program. Normally, it would be expected that a student would complete HLTH 5000 before taking HLTH 5120. However, it is possible, although not desirable, to take HLTH 5120 before HLTH 5000.
