1. This class will explore the WHY, WHEN and HOW of human behavior and ways to enhance functional behavior. Emphasis is placed on a strong knowledge base, problem solving skills and specific behavior management techniques. Specific indicators of problems, implementation of techniques and identification of appropriate referrals for additional help will also be stressed.
