<b>Catalog Description/ Content Area</b>	<b>COUN 6500 Internship</b> Internship is an intensive Counseling experience that provides the student with the opportunity to perform a variety of counseling activities expected of a professional mental health Counselor (e.g., application of diagnostic and therapeutic skills, documentation, information and referral techniques, intake, staff meetings, and weekly supervision). The internship must be in an approved setting under the supervision of an appropriately licensed on-site supervisor. A formal Internship Agreement must be completed by the student and the internship on-site supervisor and submitted to the Internship instructor prior to the initial class meeting. Students are required to abide by the <i>ACA Code of Ethics (2005)</i> in their internship experience. Students are required to provide evidence of professional liability insurance prior to seeing clients. <b>No school settings can be used for an internship site at this time, except through special permission from the counseling program coordinator.</b> Students must have completed six (6) program core courses in addition to COUN 6000/Counseling Learning Practicum, before submitting an application for the internship. This course may be repeated for credit. The internship is graded on the credit/no credit grading option. This course requires permission of instructor and or the Counseling Program Coordinator or the Counseling Program Academic Advisor. Additional minimal fees are required for this course for professional liability insurance, lab fees, and taping equipment. This course is time consuming and demanding. Students should be prepared to apply more hours to this course than to most other courses; it is recommended that students reduce full time employment to part-time employment during this course. 	<p><i>not only your academic performance but also your interpersonal skill development and openness to supervision <b>as evaluated by the instructor and or supervisor.</b> For example, it is possible to excel academically and not pass the course due to poor counseling skills development, poor interpersonal skills, and or inability to receive supervision in a professional manner. Thus, all grades will reflect a combination of <i>objective and <b>subjective</b></i> assessment.</i></p>

<p><b>Activities</b></p>	<p>The program requires completion of a supervised internship in the student's designated program area of 600 clock hours, begun after successful completion of the practicum. The internship is intended to reflect the comprehensive work experience of a professional counselor appropriate to the designated program area. Your internship is required to include all of the following:</p> <ol style="list-style-type: none"> <li>1. At least 240 clock hours of direct service (of the 600 total hours), including experience leading groups.</li> <li>2. Weekly interaction that averages one hour per week of individual and/or triadic supervision throughout the internship, usually performed by the onsite supervisor.</li> <li>3. An average of 1 1/2 hours per week of group supervision provided on a regular schedule throughout the internship and performed by a program faculty member.</li> <li>4. The opportunity for the student to become familiar with a variety of professional activities and resources in addition to direct service (e.g., record keeping, assessment instruments, supervision, information and referral, in-service and staff meetings).</li> <li>5. Evaluation of the student's counseling performance throughout the internship, including documentation of a formal evaluation at the midterm and the end term of the internship by a program faculty member in consultation with the site supervisor.</li> </ol> <p><b>Case Staffing: 20%</b> A client case will be presented by each student for class review during class meeting for a total of three case presentations for each 6000 Practicum. These cases will be expanded to include a psychosocial history and mental status exam, a diagnosis (utilizing all five axes of the DSM IV) to be turned in during the semester to receive credit.</p> <p><b>Case Chart: 20%</b> Graduate student counselors will select one client to write up a completed chart. No identifying information is allowed in the documentation. Any chart submitted with identifying information will be given zero credit. Documentation will include:</p> <ul style="list-style-type: none"> <li>○ Informed consent with HIPAA information</li> <li>○ Release of information</li> <li>○ Completed biopsychosocial assessment that includes mental status exam</li> <li>○ Treatment plan</li> <li>○ Four weekly progress notes - minimum</li> <li>○ Discharge plan</li> </ul> <p>Forms will be given to the student by the instructor if needed.</p> <p><b>Weekly Debriefing of Cases: 20%</b> Debriefing is an opportunity for the student to demonstrate their knowledge of the field of counseling. It is also an opportunity to demonstrate skills gained in the pursuit of this expertise. The student is expected to bring these in their notebooks each week to class and have the instructor review it.</p>

**Time Logs: 10%**

A time log is to be completed on a weekly basis that reflects the time the intern spends completing direct, non-direct, and supervision hours.

**Evaluations: 10%**

All students must complete the following.

- Student's Site evaluation (Typed)
- Thank you note to Site/Qualified Supervisor
- Evaluation by Site/Qualified Supervisor is to be turned in, in a sealed envelope with the supervisor's signature across the seal.

**Practicum Log Notebook: 10%**

A time log of the Practicum must be kept which includes dates, times, and situations. It should be presented to the instructor in an appropriate three ring binder for the permanent use of the student. The binder sections should be:

1. Syllabus
2. Completed Practicum Packet
3. Completed Time Log for required hours: COUN6000 40/60; COUN 6500 120/180
4. One page debriefing for all counseling done in the week

**Class Participation and Attendance: 10%**

- Students are expected to attend all class sessions of every course for the full 36 contact hours. In the case of unavoidable absence, the student must contact the instructor. The student is subject to appropriate academic penalty for incomplete or unacceptable makeup work, or for excessive or unexcused absences. Generally, a student who misses more than one four-hour course period (per course) without a documented military or medical excuse and advanced permission of the instructor should withdraw from the class. The University reserves the right to involuntarily drop enrolled students from classes, which they do not attend.  
**PLEASE BE ADVISED: Students who do not attend the first class session, who have not made prior arrangements with the instructor for being absent, will be dropped from their courses.**
- Attendance the last day of class is mandatory to ensure that all work is completed and to be awarded a passing grade. An Incomplete will not be acceptable without documental proof (Death Notice, Doctor's Letter, etc.) as to absence relating to non-completion of class work. These must be faxed 904-262-1459 or dropped off to Webster University by the Monday after the term ends.
- Participants are expected to arrive on time and be actively involved in the learning experience. Each student should desire to learn, participate, and proactively contribute to the learning of others during each discussion and exercise.
- Students are to participate in classroom discussions. The discussions are an opportunity for students to reveal their understanding of the assignments made for the current and previous classes.
- Assignments are given to prepare the student to participate in class discussions; therefore, it is imperative that reading assignments and associated questions for

	<p>discussion be completed prior to class.</p> <ul style="list-style-type: none"> <li>• A maximum of 10 points will be awarded based on the level and quality of participation and preparation.</li> <li>• Failure to turn in an assignment within one week will result in a grade of "0" for that assignment. In addition, failure to submit an assignment will lower the final grade by an additional two points.</li> <li>• All assignments are due as detailed in the Course Schedule.</li> <li>• Late assignments will be accepted, if they are turned in <b>no later</b> than one week later, but will be penalized one letter grade. <p><b>Course Policies</b></p>	<p><b><u>Self-Awareness, Safety of Disclosure, Appropriate Interpersonal Skills and ACA Code of Ethics:</u></b>  In the interaction between class members, self-disclosure and personal examination will occur. All interactions fall under the same umbrella of confidentiality as do client/counselor relationships, i.e., <b>what is discussed in the class stays in the class and is not discussed with other students outside of the course or friends.</b> Any violations of the ethical standards will be dealt with accordingly. Maintaining</p>

confidentiality is the primary ethical principle of counselors. If a student fails to maintain the confidentiality of clients or classmates, **the student risks a failing grade** in the course. In addition, the instructor will refer the breach of confidentiality to the Counseling Advisory Committee for disciplinary action of the student.

We will be learning from each other in addition to the text throughout the semester. Therefore, it is important **that everyone feels safe, comfortable, and free** to discuss and elaborate on their thoughts around their developing knowledge and skills. In class, it is important for each of us to be respectful of one another's positions; relating to others in an empathic manner occurs in class *just as with clients*. You are encouraged to make your feelings and thoughts known, yet, to **do so in a "counselor manner", i.e., respecting the position of listener while giving voice to your thoughts and using your budding counselor attending skills**. This is an opportunity for you to practice and evidence your basic skills of empathy, warmth, genuineness, and congruence by communicating in a manner consistent with a good counselor. The building of trusting alliances with your classmates is as important as doing so with your clients. Therefore, you will be practicing some of the same skills when participating in class as in counseling sessions with your clients one day.

Further, **openness to supervision and instruction** by the instructor can become an issue for some students and is, therefore, emphasized here. Openness to supervision is defined as: accepting supervision—both individual and in class; recognizing your own personal strengths, weaknesses, biases, needs, and beliefs; sensing personal and professional impact on others, both positive and negative; accepting and applying feedback from instructor; seeking out needed experiences, feedback, etc., in a proactive way; and accepting feedback in a non-defensive manner with a professional attitude.

Students who do not evidence openness to supervision and or appropriate interpersonal skills are subject to remediation by the Counseling Advisory Committee at the campus. See the student handbook and or catalog for further detail.

#### ***ACA Code of Ethics (2005)***

*Counselors-in-training have a responsibility to understand and follow the ACA Code of Ethics and adhere to applicable laws, regulatory policies, and rules and policies governing professional staff behavior at the agency or placement setting. Students have the same obligation to clients as those required of professional counselors. (See C.1., H.1.)*

#### **Cell Phones**

Turn off all cell phones during class unless otherwise advised by the instructor.

#### **Academic Integrity**

All of your work in this class should be original to you and to this class. You are expected to explore, analyze, and discuss the ideas of others, but you must give them proper credit through citations and references. You may continue to explore an area of interest, but you must do new or additional research and writing.

Recycling papers from other coursework is not acceptable.

According to the *Publication Manual of the American Psychological Association* (2001), plagiarism involves presenting the work of another as if it were your own work. It is very important that you give appropriate credit to others when you use their work. If you paraphrase someone else's work, you must also give them credit with a citation.

**All students are expected to know what constitutes plagiarism and to avoid committing plagiarism in their written work.** Plagiarism will not be excused by ignorance on the student's part. If you believe that you do not have a clear understanding of plagiarism, see your instructor immediately and before any written work is turned in.

**Course Attendance:**

The University reserves the right to drop students who do not attend class the first two weeks of the term/semester. Absences will result in a significant loss of learning, which will not be recouped through borrowing a classmate's notes. **Students are expected to attend all class sessions of every course.** It is expected that you will come to class having completed the reading assignments and will ask questions and participate in all activities.
