<b>Catalog Description</b>	<b>COUN 5100: Social Cultural Foundations of Counseling:</b> This course examines the importance of understanding cultural and ethnic attributes and the dynamics these attributes have on the counseling relationship. Attention is given to gender roles, ethnic groups, subcultures, urban and rural societies, cultural mores, and differing family life patterns.

Discuss nature of diversity and its effect on the therapeutic relationship. Study Appendix A, pp. 469-474.</p> <p><b>Wk 2:</b>Read Chs 3-4 Discuss cross-cultural communications/counseling styles and sociopolitical considerations of mistrust in cross cultural counseling.</p> <p><b>Wk3:</b> Read Ch 5 Cultural simulation exercise, Bafá Bafá and discussion of ethnic identity formation.</p> <p><b>Wk 4:</b>Read Chs 6-7 Cross cultural family counseling and the implications of individual cultural ideologies.</p> <p><b>Wk 5:</b> Mid-term exam of class discussion and chapters 1-7 of textbook. Cultural experiences in ethnic neighborhoods of Kansas City.</p> <p><b>Wk 6:</b>Read Chs 8-9 Dimensions of world views and how they affect the counseling process. Students will role-play “culturally competency” in counseling scenarios.</p> <p><b>Wk 7:</b>Read Chs 10-11 Counseling approaches to individuals from diverse communities. Reflect on fieldtrip experiences.</p> <p><b>Wk 8:</b> Individual presentations of course projects.</p> <p><b>Wk 9:</b> Final exam and wrap-up of course.</p>

<p><b>Additional Information</b></p>	<p><b>Course Requirements:</b></p> <p><b><u>Course Attendance:</u></b> The University reserves the right to drop students who do not attend class the first two weeks of the term/semester. Students are expected to attend all class sessions of every course. In the case of unavoidable absence, the student must contact the instructor. The student is subject to appropriate academic penalty for incomplete or unacceptable makeup work, or for excessive or unexcused absences.</p> <p><b><u>Conduct:</u></b> Students enrolling in a degree program at Webster University assume the obligation of conducting themselves in a manner compatible with the University's function as an education institution. Misconduct for which students are subject to discipline may be divided into the following categories:</p> <ol style="list-style-type: none"> <li>1. All forms of dishonesty, cheating, plagiarism, or knowingly furnishing false information to the University.</li> <li>2. Obstruction or disruption of teaching, research, administration, disciplinary procedures, or other University activities or of other authorized activities on University premises.</li> </ol>

3. Classroom disruption. Behavior occurring within the academic arena, including but not limited to classroom disruption or obstruction of teaching, is within the jurisdiction of Academic Affairs. In case of alleged campus and/or classroom disruption or obstruction, a faculty member and/or administrator may take immediate action to restore order and/or to prevent further disruption (e.g. removal of student[s] from class or other setting). #### **Professional Skills Evaluation**

The Professional Skills Evaluation (PSE) will be used in this course for ethical and regular evaluation of professional counseling skills development. It was developed based on proficiencies seen as necessary to succeed in the field of professional counseling and aligns with ACA Code of Ethics (2005) and professional standards (CACREP 2008-09). It will be administered to all students in this course. The PSE will be administered at midterm and at end term. The professional judgment of the instructor is used within the administration of the PSE; the instructor's subjective and professional opinion is inherent in this process. The instructor will meet with any students with significant deficiencies in course-related skills. Confidentiality will occur throughout this process. PSE's will be filed in student's file.

#### **Course Contact Hours:**

Unless a course has enrolled fewer than four students, faculty has a contractual obligation to meet the full complement of contact/meeting hours (36 for graduate courses). Not to meet this full complement of hours may be construed as a breach of contract and may also endanger Webster University's accreditation by The Higher Learning Commission, a commission of the North Central Association of Colleges and Schools, and its licensure by the State. Finally, course meetings which are missed for any reason must be made up.

**Determination of Grades is Based On the Following Criteria:**

Minimum Requirements:

Products (papers, case studies, projects) must be on time, in the correct format, corrected for spelling and grammar, appropriate materials included and referenced to-the-point and on topic and conclusions must be supported.

Examinations must be complete, accurate, neat, evidence clear thought, and exhibit concise and to-the-point responses.

Behavior in class discussions and group activities should be responsible, should exhibit open communication, be constructive, and helpful.

Mastery Level (Grade of "B"): Professional Achievement

Products must meet the requirements stated above for minimum requirements and additionally meet professional criteria. For example, documentation should be included to support research papers, the APA format should be used consistently throughout the paper, and substantially more than the minimum number of references should be included. Presentations should be logical, organized, and comprehensive.

Examinations should be organized, in depth, comprehensive, logical and complete, and evidence thorough understanding of the subject /topic through application of principles.

Classroom behavior should exhibit very focused activity and thought on the subject at hand, be motivated, and assist in discovery of new insights and relationships concerning the subject/topic of discussion.

Mastery Level Plus (Grade of "A"): Creative Achievement

Products must meet all requirements stated above and additionally meet creative criteria. These criteria include unique topic or subject selection, synthesis of ideas, evaluation of subject matter and positions found in the literature, be creative in approach, establish new relationships with ideas and provide new insights.

Examination responses indicate insightfulness of understanding, a synthesis of information and unique ideas, and rationale for application of principles following careful analysis.

Classroom behavior should exhibit very focused activity and thought on the subject at hand, be motivated, and assist in discovery of new insights and relationships concerning the subject/topic of discussion.

The grade of "A" represents the best work of students, accomplished in a unique and professional manner.
