Catalog Description/ Content Area	<p>COUN 6500: INTERNSHIP Intensive counseling experience that provides the student with the opportunity to perform a variety of counseling activities expected of a professional mental health counselor (e.g., application of diagnostic and therapeutic skills, record keeping, information and referral techniques, in-service and staff meetings). The field experience must be in an approved setting under the supervision of a licensed on-site supervisor. Students must have completed all nine (9) program core courses and required COUN 6000 Counseling Learning Practicum before submitting an application for the field experience. Course may be repeated for credit. The field experience is graded on the credit/no credit grading option. Requires permission of instructor/academic advisor.</p> <p>Content Area: Helping Rxs, Human Growth and Development, Social and Cultural Diversity, Professional Orientation and Ethics, Group Techniques, Assessment, Career Development. Clinical practice in specialty area.</p>
Learning and Skills Outcome Objectives	<p>Upon successful completion of this class students will be able to:</p> <ol style="list-style-type: none"> 1. Demonstrate technical proficiency in the clinical use of assessment, counseling theories, multicultural issues, and counseling skills in various counseling settings. 2. Demonstrate proficiency in the legal and ethical issues involved in boundary issues, referral, termination, storage of records, assess to records, informed consent, and confidentiality. 3. Demonstrate mastery of the role played by racial, ethnic and cultural heritage, nationality, socioeconomic status, family structure, age, gender, sexual orientation, religious and spiritual beliefs, occupational, physical, and mental status, local, regional, national, and international perspective, and equity issues in counseling. 4. Demonstrate a mastery of professional identity through professional memberships and initial State licensure engagement .

Method of Learning	Class will be primarily in discussion format and will count toward your Group Supervision hours. You will be sharing issues, cases, problem areas, new learning, tapes of sessions, and will be receiving constructive feedback on a continuing basis.
Grading	<p>In order to receive the grade of CR (credit) for this course, all hours must be completed satisfactorily. Supervisor evaluations and class requirements must be satisfactory and complete. Class attendance and participation is mandatory. All assignments are due at the beginning of each class and must follow the specific requirements given (i.e., typed, double-spaced, etc). Excused absences are rare as a major portion of the class involves your participation and active processing.</p> <p>The Graduate catalogue delineates the grading process for this course. The course is graded on a credit/no credit format. In other words, no letter grade is provided and the student will receive credit for passing the course and no credit for not passing the course. It is imperative to note that the grading of this course has a subjective component that is based upon the experience of the instructor. The Counseling faculty recognizes that counseling skills and counselor effectiveness cannot be assessed in the same manner as academic performance in other disciplines. Students completing this course should <i>demonstrate marked progress toward the course objectives</i> as noted above as well as be able to write coherently and interact professionally with peers. Your final grade (credit or not) in this course will reflect <i>not only your academic performance but also your interpersonal skill development and openness to supervision as evaluated by the instructor and or supervisor</i>. For example, it is possible to excel academically and not pass the course due to poor counseling skills development, poor interpersonal skills, and or inability to receive supervision in a professional manner. Thus, all grades will reflect a combination of <i>objective and subjective</i> assessment.</p>

	<p>Course Requirements:</p> <p><u>Course Attendance:</u> The University reserves the right to drop students who do not attend class the first two weeks of the term/semester. Students are expected to attend all class sessions of every course. In the case of unavoidable absence, the student must contact the instructor. The student is subject to appropriate academic penalty for incomplete or unacceptable makeup work, or for excessive or unexcused absences.</p> <p><u>Conduct:</u> Students enrolling in a degree program at Webster University assume the obligation of conducting themselves in a manner compatible with the University's function as an education institution.
